External Hyperlink Policy

1. Introduction and Purpose

This External Hyperlink Policy ("Policy") outlines the principles and guidelines governing the creation, management, and use of external hyperlinks on the website and digital platforms of The Karad Urban Co-operative Bank Ltd; Karad ("the Bank," "we," "us," or "our"). 2. Definition of External Hyperlink

An "External Hyperlink" refers to any clickable element (text, image, button, etc.) on Bank's website or digital platforms that, when activated, directs the user to a different website or digital platform not owned, operated, or controlled by Bank. This includes links to partner websites, regulatory bodies, news articles, educational resources, or any other third-party content.

3. Policy on Providing External Hyperlinks

Bank may provide external hyperlinks on its digital platforms under the following conditions and considerations:

3.1. Informational and Convenience Purposes

External hyperlinks are provided solely for the convenience of our users and for informational purposes. They are intended to offer supplementary resources that may enhance the user's understanding or provide access to related services. The presence of an external link does not constitute an endorsement, recommendation, or guarantee by Bank of the linked website, its content, products, services, or its operators.

3.2. No Endorsement or Responsibility

Bank explicitly states that it does not endorse, approve, certify, or control these external sites or their content. We are not responsible for the accuracy, completeness, legality, or content of the external site or for that of subsequent links from that site. Users acknowledge and agree that Bank shall not be held liable, directly or indirectly, for any damage or loss caused or alleged to be caused by or in connection with the use of or reliance on any such content, goods, or services available on or through any such external sites or resources.

3.3. User Discretion and Risk

Users who click on external hyperlinks do so at their own discretion and risk. Bank strongly advises users to exercise caution and judgment when navigating to external websites. It is the user's responsibility to review the terms of use, privacy policies, and security practices of any third-party website before engaging with its content or providing any personal information.
